
#### Security and safety

#### **Keynote Speaker**

**Rob Jackson,** is Director of Rob Jackson Consulting Ltd, a consultancy and training company that helps engage and inspire people to bring about change. Rob has almost 30 years experience working in the voluntary and community sector, holding a variety of strategic development and senior management roles that have focused on leading and engaging volunteers. Rob has run his company since 2011 working with a wide range of clients in the UK, Australia, New Zealand, Europe, the USA and Canada. Rob is co-author of The Complete Volunteer Management Handbook (DSC, 2012 and 2019) and From The Top Down - UK Edition (Energize Inc., 2015).



#### Keynote speaker

**Dermot Murphy** is the RSPCA Chief Inspectorate Officer and is responsible for all Inspectorate operations across England and Wales. Dermot has been with the RSPCA for 28 years and after starting as an Animal Ambulance Driver in London, he became an Inspector, Chief Inspector and Staff Officer in the Inspectorate Department with a responsibility for policy development. Dermot has been in his current role for 7 years.



Adam Clowes joined Dogs Trust in 2001, bringing extensive operational experience from his previous roles in the military, Aldi and at Royal Mail. At Royal Mail, Adam held a number of operational positions, focusing on organisational transformation and delivering complex frontline services. Before that, he served four years with the Royal Signals, having graduated from Royal Military Academy Sandhurst, and then subsequently achieving an MBA from the University of Birmingham. He became a trustee of the Association of Dog and Cats Homes in 2018, playing an active role on the Standards and Animal Welfare Committee and supporting members through chairing various webinars and open meeting sessions. Prior to joining Dogs Trust Adam had adopted from both Dogs Trust Salisbury and then Kenilworth.



Since April 2020, **Adam Stanley** has worked at Blue Cross for Pets as the Head of Rehoming Service Design and latterly the Head of Services & Products Design & Development. He oversees the design and development of compelling and impactful experiences for Blue Cross's service customers, taking a particular interest in drawing linkages and synergies between the wide range of services that Blue Cross offers. Prior to that, Adam has almost a decade of experience working in service design on the railway and in policing, before moving into the animal welfare and rescue sector two and a half years ago.

As someone who was recently diagnosed as autistic, Adam also speaks passionately about neurodiversity, accessibility and inclusion, and applies this to both the customer experience as well as for employees and volunteers providing those services.

He is the behaviour consultant for Pet Remedy and the British Isles Grooming Association and is a Canine Arthritis Management Expert Advisor. He is the behaviour consultant for Animals in Distress, and also works to support many dog rescue organisations around the UK. With a human psychology background, Andrew is passionate about exploring the emotional experience that lies behind behaviour, both in dogs and the humans around them. Andrew has played a leading role in the UK Dog training and behaviour community, having been the chair of the Association of INTODogs, and being the driving force behind the UK Dog Behaviour and Training Charter.

In 2020, Andrew started Dog Centred Care, which focusses on supporting a dog led approach to providing the best care and support. Within the online FB Dog Centred Care group, he has been hosting on-line conversations with some of the world's leading trainers, scientists, researchers, trauma experts and veterinarians. These conversations are credited with helping transform the perceptions and language around dog training and behaviour.

**Catherine Rustomji,** is Partner & Head of Charities at Shakespeare Martineau. She has been advising charities, social enterprises and not for profit organisations exclusively for over 20 years. Catherine is a specialist charities solicitor who advises charities, not for profit organisations, social enterprises, charity trustees and individuals wishing to establish charities. Her particular focus is on constitutional and governance matters including different legal structures and the duties and responsibilities of charity trustees. She regularly advises on charity registrations, incorporations of existing charities, mergers, the use of commercial subsidiaries including community interest companies and advising on the legal duties and responsibilities of charity trustees.

Driven by an ethos to Do More Good, Chris has worked with charities of all shapes, sizes and budgets to support them in smashing their goals.

**David Bowles** has been a Board member of ADCH since 2015, leading on analysing the ADCH annual returns and Covid-19 surveys and delivering the insights to members, Governments and legislators. As Head of Public Affairs and Campaigns at the RSPCA and a member of Defra's expert group on dogs and cats, David uses his legislative knowledge leading on this work for ADCH and analysing impacts of the cost of living on the sector. The RSPCA was the first animal welfare organisation in the world and was set up to investigate and prosecute animal welfare offences. In 2021 it received some 1.1 million calls a year to its cruelty line, investigated 51,000 complaints and dealt with over 138,000 welfare incidents. ADCH faces three important challenges in the coming year: delivering assistance and information to members as the cost of living starts to impact the sector, assessing what is happening on the ground as we crack down on the illegal puppy trade and ensuring ADCH is centre as rescue licensing is introduced.



Ellie Cannell is Head of Human Resources at Battersea Dogs and Cat Homes

#### Kris Glover, Head of Clinical Behaviour Services, Dogs Trust

Kris started with Dogs Trust as a Clinical Animal Behaviourist in April 2018. In February 2019 she took on the role of Manager for the Clinical Animal Behaviour team and in November 2021, became Head of Clinical Behaviour Services.

Previous to her employment with Dogs Trust Kris was self-employed and ran a private behavioural and training practice based in Berkshire from 2004-2018.

During her 18 year career in the pet behaviour industry Kris has seen over 4000 dog behaviour cases, and around 1000 cat behaviour cases. Behaviour problems she has worked with range from separation-related issues, sound phobias, people and dog aggression as well as some more unusual cases such as idiopathic overnight bed wetting.

Kris very much enjoys working with humans and their pets and has a special interest in how the relationship between dog and owner influences the success of behavioural rehabilitation programmes.

Kris has a BA (Hons) degree in Companion Animal Behaviour Counselling and an MSc also in Companion Animal Behaviour Counselling. Kris is a Certificated Clinical Animal Behaviourist (accredited through ASAB) and a member of FABC.



**Laura Messenger** is the Funding and Partnerships Manager at the Pets at Home Foundation. Her team looks after the relationships the Foundation has with their beneficiaries, through their grant support and Community Partner programme. 
